

# AHC: Art Hub Residency

#### CONTENTS OF THE PROGRAM

- A studio at Thoravej 29, access 24/7. The studios are between 13 and 35 square meters and are distributed according to needs.
- Access to Thoravej 29's five workshops, access 24/7. Read about them here.
- A fee of DKK 21.000 incl. VAT per month.
- Meetings with relevant mentors and curators. The artist selects one or two mentors and one or two curators that the person wishes to meet. In addition, AHC arranges two or three mandatory meetings with relevant curators and professionals.
- Ongoing professional sparring and feedback. Including monthly meetings with curator Marie Braad Larsen.
- A digital publication that conveys the resident's practice, based on an interview, made by a professional writer/curator. 1000 words and pictures, which are published on AHC's website.
- In addition, dissemination of practice on AHC's social media.
- Conducting a dissemination activity.

#### WHO CAN APPLY?

Visual artists who are citizens of an EU/EØS country, have a permanent residence permit or are otherwise entitled to stay in Denmark for a continuous period of five months.

All professional visual artists can apply for participation in this residency. You must either be educated from the Jutland Academy of Arts, the Funen Academy of Arts, the Royal Danish Academy of Arts or have a similar professional visual arts education or background. It is possible to apply as a duo.

## **REQUIREMENTS FOR APPLICANTS**

- It is expected that you, as part of the residency, spend your daily life at Thoravej 29. Shorter journeys etc. during the period is agreed in advance.
- Together with AHC's team, you must plan and execute a presentation that conveys your work.
- Throughout the course, you must participate in monthly meetings with Marie Braad Larsen.
- You must participate in a visiting program with selected art institutions.
- You must agree to spend time giving an interview to a writer/curator who will write a text about your practice as well as reading through and possibly less post-editing. You must also agree that your practice and residency will be communicated on AHC's website and social media.

#### **HOW TO APPLY:**

To apply, you must complete the application form (right-click on link and select "open link in new tab", select download. The form is a word file). The form is filled out in English.

The completed form is sent together with the CV incl. contact information (max. 1 A4 page) and image material including short descriptions (max. 4 A4 pages), as a combined pdf file of max. 5MB.

The application is sent to ansogning@arthubcopenhagen.dk. Write "Art Hub Residency 2025" in the subject field.

Deadline for application: 17 November 2024 at 23.59.

#### **JURY**

All applications will be reviewed by an artistic jury, which in collaboration with AHC will select the final candidates. Short interviews will also be conducted before the final selection.

Art Hub Residency is run on a day-to-day basis by curator Marie Braad Larsen, who will also be the residents' contact person throughout the process.

# FAQ: Art Hub Residency

## Can my application be disqualified due to formalities?

Yes, AHC automatically dismisses applications that:

- are submitted in more than one file
- are not in PDF format
- do not adhere to our application guidelines

For example: If we request a one-page CV, applications containing a two-page CV will be automatically dismissed. We therefore ask applicants to pay close attention to the specifications given regarding the length of the requested documents, their format and language, the form we provide, and any geographical restrictions.

Furthermore, we only accept professional artists to the residency, meaning artists who have graduated from an art school or educational programme related to their artistic practice.

### Will I be notified if my application is invalid?

If there are issues with the format of your application and you submit it before the deadline, we will do our best to inform you. For your application to be valid, the application must be corrected and resubmitted before the deadline. We do not accept corrected applications submitted after the deadline.

# How can I be sure you received my application?

You will receive an automatic reply from our system as soon as you submit your application. If you do not receive a confirmation email from us within an hour after submitting the application, please email us at ansogning@arthubcopenhagen.dk before the deadline of the open call. Remember to check your spam folder.

#### I am from the UK. Can I apply to your residency?

For legal and administrative reasons, AHC can only accept applications from the EØS (see list of countries here). Unfortunately, the UK is not an EØS country, which means that AHC cannot accept applications from UK-based artists.

# Can I get personalised feedback after a rejection?

No, we are not able to provide personalised feedback on rejected applications.

### Who are the jury members?

All applications will be reviewed by a jury of art professionals. In collaboration with Art Hub Copenhagen, the jury will select the final candidates for the Art Hub Residency. We will announce the selected artists and jury members simultaneously.

#### Is there an age restriction for applying to an AHC residency?

Applicants must be at least 18 years old. There are no other age restrictions.

# I am an artist with a practice centred on performing arts (theatre, dance, physical performances). Can I apply?

Yes, we welcome applications from artists in the performing arts. However, please note that there may be limitations in terms of our facilities, as we cannot accommodate e.g. performance, dance and theatre rehearsals that require a larger space. Please consider whether the facilities described in the open call will suit your practice.

# I don't have Word on my computer. How do I fill in the application form?

Download the Word form and open it in Google Documents. After completing your application, make sure to export it as a PDF before submitting it.

# Nothing happens when I click on the link to the form mentioned in the open call. How can I download it?

Right-click on the link and select 'open link in new tab', then select 'download'. The form will be downloaded to your computer.

# I had a personal or technical issue with my application. Will it be accepted if I submit it after the deadline?

Unfortunately, we cannot make exceptions for personal or technical issues due to the subsequent processing of applications. Any application submitted after the deadline will be automatically dismissed.

## Can duos or collectives apply?

Yes, you are welcome to apply as a duo or collective.

Can the partner, child(ren) and/or dependents of international residents be accommodated? Yes, we will do our best to accommodate you and your family or dependents during your five-month stay in Copenhagen.

# How can I request specific accessibility support?

Art Hub Copenhagen welcomes applicants from all backgrounds, including disabled and neurodivergent artists and others who have specific needs. We are open to discussing how our residencies can be adapted to meet the needs of selected applicants.
